## RESTRICATION ON TRANSFER OF SHARES IN PHYSICAL FORM WITH EFFECT FROM DECEMBER 5, 2018

- In terms of Amendment to Regulation 40 of SEBI (Listing Obligations and Disclosure Requirements), 2015 carried out through a notification dated 05.07.2018, Companies and their RTAs shall not be allowed to process share transfer of securities in physical mode w.e.f 05.12.2018.
- This restriction shall not be applicable to the request received for transmission or transposition of physical shares.
- Thus, effective December 5, 2018, the shares of the Company can be transferred only in dematerialized form as per the said SEBI notification.

BSE Limited ('BSE') has issued Circular on July 05, 2018 to this effect, directing the listed companies to prominently place the said information on their website intimating the shareholders about the proposed change and provide appropriate guidance on how to dematerialize their shares.
